Criteria for judging:

The Club must have achieved the following:

- Has taken part in a Blind Low Vision NZ collection or given a donation
- Has been involved in local publicity within this District
- Has taken part in the eye glass collection or other activity (see additional notes below)
- Has made other clubs in the area aware of the programme e.g. discussed at zone meet

Additional Notes:

As a guide to clubs, activities could be:

- Support Blind Low Vision Library
- Eye Bank support encouragement
- Establish working relationship with local clinics and professions to be utilised in public awareness and screening for vision loss
- Provide funds for guide dogs and lens testing
- Provide large print books etc.
- Assist in providing employment for the blind / low vision
- Reading to the blind / low vision
- Recreational activities for the blind / low vision

Presentation:

An overview of particulars of the Project being presented should be contained in a brief written digest form of not more than one A4 both sides. It may be accompanied by additional information and evidence that can be transmitted electronically such as newspaper cuttings, letters of congratulations, references, reports circulars and any such data to enlighten and impress the judges on the various phases of the Project.

The generic entry form should be placed at the front of the presentation.

Timeline:

The dates and duration of the entire project must be clearly shown. In this instance the entire project may cover more than a Lions year with completion occurring within the previous Lions year timeframe.

Finance:

Evidence should also be given of the method of financing the project, origin of project, costs and control of Budget, handling and payment of accounts and a final statement of expenditure showing proceeds made available to selected charity or project.

Criteria for judging: **(Please use the Keith Mitchell Award table – Appendix 2, Item B)**

1. Clubs must have achieved 100% Monthly Membership Report (MMR) on MyLCI
2. % increase of new members for the year against club membership as at 1 July points scored on Ratio of 1:10 (1 point per 10%)
3. Points awarded for new members scored on ratio of 1:1
4. Net membership increase ratio of 3:1 (3 points each net new member)

All District entries are to be judged in sufficient time so that the top District entry can be confidentially advised and forwarded to the MD Secretary by the 31st January of each year. The Council Chairperson will select the final winning entry from those submitted.

The areas to be covered by the award are as follows:

- Membership Growth = 1 point for new (not transferred or reinstated) member **retained for 12 months plus one day.**
- Extension = 10 points for each new club sponsored plus 1 point for each Charter (not transferred) member.
- Retention = 3 points for net membership increase since 1st July (per member increased).

Continued.....

The club with the most points from all categories will be judged the winner.

However, should more than one club have the same number of points based on the above then the winner shall be determined on the basis of the % increase of new members against the clubs total membership for that fiscal year. Therefore the club with the greatest % increase in club membership would be judged the winner.

If by any chance that a tie is still recorded then the award is to be shared.

2. List of activities the Lions member has participated in, in their community, as an individual (not under the banner of their Lions club) in the past Lions year demonstrating the spirit of Lionism.
3. The nominee has not been a recipient of this award in the preceding 5 years

Additional Notes:

Service as a Lion within one's own community is paramount. Service as a Lion at District or Multiple District level is not part of the judging criteria.

The Christchurch South Lions Club retains ownership of the Trophy

The Trophy is to be awarded annually at the District Convention.

Each year, the date and name of the winner, with a very brief description of the achievement (if possible), is to be engraved on a small plaque attached to the base of the Trophy.

The Immediate Past District Governor will announce the winner at the District Convention and at his/her discretion will invite the President of Christchurch South Lions Club to make the presentation.

When announcing the winner the Immediate Past District Governor should advise Convention that the Iain Drewett Trophy was made available by Christchurch South Lions Club.

4. Club social media page = 10 points
5. Other forms of communication or publicity = 10 points
6. Club has a Marketing Communications Chairperson = 5 points

 - 10 points for winner's sponsoring club
- 2 PEACE POSTER COMPETITION**
 - 10 points per club entry
 - 10 points for club sponsoring District winner
- 3 YOUTH CAMP**
 - 10 points for club sponsoring entrant to International or Internal Youth camps

4 ENVIRONMENT COMPETITION

- 10 points for sponsoring entry in District competition for clubs

Where an activity is shared, the points are to be awarded on a proportional basis.

Total number of points to be divided by the District Voting Entitlement at the end of the Lions year.

This competition to coincide with the Lions year dates of 1st July to 30th June inclusive.

Additional Notes:

On a separate sheet or in any manner the Club feels is appropriate, detail the areas in which the Club has been involved with young people. Any support material (eg. photographs, newspaper clippings etc) must be able to be submitted by electronic means.

This cumulative total of youth activities does not meet the MD Youth Award. The IPDG and Youth chair reserve the right to choose the best single youth activity from any of the entries to be the 202E entry submitted for the MD Pat Ryan Youth Award. A club may submit an entry solely for consideration for the MD Pat Ryan Youth Award. See appendix 3 202/5 for criteria. The entry selected will be acknowledged at the awards ceremony as the winning single youth project.

- 20% -originality of project
- 20% -report presentation, including appropriate diagrams, graphs, plans, photos

Additional Notes:

Any project undertaken by a school, (or individual classes from a school) which aims to increase the involvement of its pupils in the improvement of, or a greater understanding of the environment, could be eligible for this competition.

School entry must be submitted by a Lions Club which may, or may not, have been involved in the project, along with the school. A Leo Club environmental project, supported by their sponsoring Lions club, qualifies for entry.

The Kaikoura Lions Club Shield is awarded to the best project along with cash prizes. A competition entry fee or the annual Youth programmes fee is paid by the Lions club.

Contestants will also deliver an impromptu speech of not more than 2 minutes on a topic determined by the judges. Penalty points apply after 2 minutes

Additional Notes:

District Finals will be held throughout New Zealand before the end of June to determine up to 3 winners per District (dependent on the number of competitors). District winner and place getters are awarded cash prizes.

These winners will travel to the Multiple District Finals mid-August/September. All travel to the finals is at the expense of NZ Lions Clubs. Funding coming from the \$50 per contestant that each District forwards to the MD Co-ordinator.

Entry fee of \$75 per contestant, paid by the sponsoring Club to the District Treasurer. The District retains \$25 of this, to fund District Contest. No entry fee paid if the Club has paid the District \$100 youth fee.

The District finalists will present two speeches for the MD finals.

The Multiple District Winner's and place getter cash prizes are outlined on the MD website.

Appendix 4

DISTRICT 202E AWARDS SOP

PURPOSE:

District awards are a way of recognizing the service of Lions Clubs and individual Lions in the District within the past Lions year. The District Awards programme is promoted by the DG, IPDG, Vice District Governors, Zone Chairs and District Bulletin Editor.

GUIDELINES:

1. Criteria is judged on the previous Lions year only.
2. Individual awards relate to the work of a Lion within their club and community – not their work at District level.
3. Clubs must submit applications for all awards (except the Bulletin Award) using the District 202E Awards Entry form.
4. Supporting information should be related to the criteria outlined in the District 202E Club Awards document.
5. The District Bulletin Award is automatic entry for clubs who send their bulletins to the DG, IPDG and District Bulletin Editor
6. Entries are to be submitted electronically by September 30th of the current year to the Immediate Past DG email: 202e.ipdg@lionsclubs.org.nz
7. The IPDG will appoint to the awards committee 1 cabinet member from zones 1 - 4 and 1 cabinet member from zones 5 – 8 to review the applications, decide on the top 3 applicants and the winning entry.
8. The IPDG is responsible for collecting the trophies (suggested at the November cabinet meeting), cleaning and engraving.
9. The IPDG is responsible for running the awards presentation at the District Convention in March.
10. Prior to this convention the IPDG must inform and submit the District winning entries that are eligible for the 4 Multiple District Awards (Keith Mitchell membership award, Pat Ryan youth award, Ron Usmar project award and Ron Rowe marketing and communications award) to the MD secretary: md202.secretary@lionsclubs.org.nz

11. The District GST is responsible for promoting and securing entries for the CA7 Kindness Matters award and the CA7 Top Club Service Project award. The District GST, DG and IPDG will decide on the winning entry to go forward to the Multiple District. These awards have different closing dates to the District awards. Entry forms and information will be circulated to clubs by the District Secretary.

12. The District GST is responsible for submitting a 'Success Story' to LCI and securing that monetary reward. How that money is used is at the discretion of the District Governor in consultation with the District Treasurer.

13. Clubs, who meet the criteria for the Club Excellence Award, should submit their entry on the LCI Club Excellence Award Application form (downloaded from the LCI website) to the District Governor before the 27th August so the DG can sign off and meet the 31st August deadline.

14. The District Governor is responsible for presenting the Club Excellence Awards at the District Convention.
